The following must be submitted in applying for the registration and certification of a PWC under 5 metres:

A. Registration of a Jet Skis

1. Completed application form (PWCJA)
2. Proof of Ownership
 - i. (Bill of Sale/Declaration)
3. Qualification of Owner
 - a. Individual
 - i. Jamaican Passport
 - ii. Drivers Licence
 - b. Entity
 - i. Certificate of Incorporation
 - ii. Notice of Directors
 - iii. Good Standing
4. Payment of Fees
5. Tourism Product Development Company Consent for Operation (Commercial Vessels).
6. Evidence of Insurance coverage to be submitted after Registration (Private)

B. Application for certification of a vessel under 5 metres;

1. Jamaican Identification
 - a. National ID; or
 - b. Jamaican Drivers' Licence
2. Certificate of Incorporation
3. Proof of Ownership
 - a. Bill of Sale for the Vessel
 - b. Paid Invoice
4. Appropriate Fees
