- To appear before and make applications to Registrars, Agencies or Departments of Government or other Authorities in relation to the registration and operation of the Yacht and to sign such documents and take such steps, which may be necessary in connection with this matter.
- Generally, to make, sign, execute and deliver any such instruments, acts and things as the said Attorney(s) shall in his absolute discretion deem desirable or expedient for carrying out any of the purposes or acts hereby authorized.
- To name or appoint (or if in Jamaica, to act as) a Ship Manager, Managing Owner or Agent (Authorized Representative) for the yacht, in accordance with Section 20A of the Shipping Act.
